Reference is made to the [notification dated 15 May](#) regarding the third informal virtual meeting of Heads of Delegation (HODs) to the INC, scheduled to take place on 3 and 4 June 2026. To facilitate participation across time zones, the meeting will be held in two alternative sessions. All session times are in East African Time (GMT+3):

- Session 1: **3 June 2026**, 14:00 – 16:00
- Session 2: **4 June 2026**, 00:00 – 02:00

Delegations are kindly informed of the **following practical information**:

Interventions

- Delegates may register to attend one or both sessions of the meeting.
- As the two sessions constitute a single meeting, Members are encouraged to deliver their intervention during only one session. Should a Member that has already intervened during the first session request the floor again during the second session, this will be treated as a follow-up intervention and, time permitting, will be taken after all Members wishing to intervene for the first time have been heard.
- Speakers representing groups of Members are requested to limit their interventions to five minutes.
- Speakers representing individual Members are requested to limit their interventions to three minutes.
- A timer for each speaker will be made available on the screen. Delegations are kindly requested to adhere to the time limits to facilitate an efficient and inclusive exchange of views.

- A separate e-mail containing the link to join the meeting on the Interactio platform will be sent directly by Interactio to the e-mail addresses provided by the registered delegates by Monday 1 June 2026.
- Please note that the same link for the Interactio platform will be used for both sessions of the meeting.
- Delegates are advised to check their spam or junk folders, as some government email accounts may block or filter external messages.
