2. Briefing on the preparations for the resumed third session of the ad hoc open-ended working group on a science-policy panel to contribute further to the sound management of chemicals and waste and to prevent pollution

The Secretariat will provide an update on the implementation of UNEA resolution 5/8 on a science-policy panel to contribute further to the sound management of chemicals and waste and to prevent pollution, with a specific focus on the preparations for the resumed third session of the ad hoc open-ended working group (OEWG-3.1) which will be hosted by the Government of Uruguay in Punta del Este, from 15 to 18 June 2025. The Committee is invited to take note of the briefing and engage in an exchange of views with the Committee Members and the Secretariat.

3. Contribution of the United Nations Environment Assembly to the High-level political forum on sustainable development.

The United Nations Environment Assembly (UNEA), in its [resolution 3/3](#), paragraph 3, and [decision 6/5](#), requested the Committee of Permanent Representatives to consider a written contribution to the High-level political forum on sustainable development (HLPF). The Committee is invited to consider a draft contribution of UNEA to the meeting of the HLPF scheduled to be held from 14 to 23 July 2025, under the theme “Advancing sustainable, inclusive, science- and evidence-based solutions for the 2030 Agenda for Sustainable Development and its Sustainable Development Goals for leaving no one behind”. This document has been prepared by the Secretariat and circulated on 17 February 2025, based on written inputs received from Member States on the initial draft circulated on 3 February 2025.
