The Secretariat will brief on the status of credentials submitted to the seventh session of the United Nations Environment Assembly, followed by an exchange of views. The Secretariat will also brief on the status of nominations of candidates for the Bureau for the eighth session of the United Nations Environment Assembly, followed by an exchange of views. Finally, the President of UNEA will update on the chairing of the meetings to be held during UNEA-7.
